Reports:

We will have the plaque dedication, election, and Bill and Betty speaking. This year we will hold the Annual Meeting in the Museum main building.
- **7. Audit-** Carrie will send updated forms. The audit committee will sign the audit and the next meeting it will be offered for approval.
